I, George McDaniel, being of weak and feeble body but of sound mind and reason do make, constitute and appoint this my last will and testament.

1st. I will and bequeath to my beloved son Joseph H. McDaniel, to my daughter Mary Francis McDaniel intermarried with William M Ware of Virginia, and to my grandson John Preston McDaniel each one dollar.

2nd. I will and bequeath to my beloved son John J. McDaniel all that portion of my deceased brother Lindsey McDaniel's estate, which he bequeathed to me in his will, to be used by him said John J. McDaniel for the support and maintenance of my beloved wife Elizabeth McDaniel during her natural life, and at her death, whatever remains to be his said John J. McDaniel, his heirs and assigns absolutely forever.

3rd. I do hereby appoint John J. McDaniel sole executor of this my last will and testament.

In testimony whereof, I hereunto set my hand and seal in the presence of two witnesses will write their names hereto at my request on the nineteenth day of January A.D. 1850
