Summary. This Indenture made this fifth day of August, in the year of our Lord, 1765, between **Leonard Goff, son of John Goff deceased, & Ann his wife of the County of Amherst of the one part & George McDaniel of the same County** of the other part, witnesseth that the said Leonard Goff & Ann his wife, in consequence of an agreement made between the said George McDaniel & the late John Goff & for & in consideration of five hundred [500] acres of land lying in Amherst County in the branches of Stovals Creek, & by the said George McDaniel conveyed to Leonard Goff & by deed bearing equal date with these presents the receipt of which the said Leonard Goff & Anne his wife doth hereby acknowledge & every part & parcel thereof doth clearly acquit, exonerate & discharge the said George McDaniel hath granted, bargained & sold, aliened & confirmed & by these presents doth grant, bargain & sell, alien & confirm unto the said George McDaniel & his heirs one certain tract or parcel of land containing one hundred & fifty three [153] acres lying & being in the County of Amherst on the Branches of Harris's Creek ... & now in the possession of the said George McDaniel with all houses ... In witness whereof the said Leonard Goff & Anne his wife hath hereunto set their hands & seals.

At a Court held for Amherst County at the Court House the fifth day of August 1765. This Indenture with the receipt endorsed were acknowledged by the within named Leonard Goff and with the certificate of the acknowledgment thereof ordered to be recorded and Anne, wife of the said Leonard being first privitly examined as the law directs came into Court and voluntarily relinquished her right of dower in the estate conveyed by the said Indenture, and Ann Goff, widow & relict of John Goff, deceased, father of the said Leonard Goff, who had also a dower in the estate came into Court & relinquished it.

This Indenture made 5 Aug 1765 between George McDaniel & Margaret his wife of the County of Amherst of the one part & Leonard Goff, Joseph Goff, John Goff, Ambrose Goff & Elijah Moran [husband of Elizabeth, daughter of John Goff, deceased] of the same County ... George McDaniel & Margaret ... in consequence of an agreement made with the late John Goff, deceased & for & in consideration of one hundred & fifty three [153] acres of land in Amherst County on the branches of Harris's Creek to him conveyed by Leonard Goff, son & heir of John Goff, deceased by deed bearing equal date with these presents the receipt of which he doth hereby acknowledge & of every part &

parcel thereof doth clearly acquit, exonerate & discharge the said Leonard Goff, Joseph Goff, John Goff, Ambrose Goff & Elijah Moran, hath granted, bargained & sold, aliened & confirmed & by these presents doth grant, bargain & sell, alien & confirm unto the said Leonard Goff, Joseph Goff, John Goff, Ambrose Goff & Elijah Moran & their heirs, two certain tracts or parcels of [land] containing five hundred [500] acres & being in the County of Amherst on the branches of Stoval's Creek, four hundred [400] acres of which was granted to Sarah Lynch by patent bearing date 20 Sep 1759 & is bounded as followeth (to wit): beginning at pointers & running etc..., the other tract being one hundred [100] acres was also granted to the said Sarah Lynch by patent bearing equal date with the former & is bounded as followeth (to wit): beginning at pointers ... (Reserving to Anne Goff, widow & relict of John Goff, deceased the plantation whereon she now lives during her natural life or widowhood, which, is in lieu of her dower in the one hundred & fifty three [153] acres before mentioned & now in the possession of the said Leonard Goff, Joseph Goff, John Goff, Ambrose Goff & Elijah Moran & to be divided amongst them agreeable to the last Will & Testament of the said John Goff, deceased, referenced there unto being had will more fully appear, with all houses etc ... To have & to hold the said land & ... unto the said Leonard Goff, Joseph Goff, John Goff & Elijah Moran their heirs ... (except as excepted).
